COUNTY-WIDE PROJECTS

County Parks Strategic Plan

The Department held three community meetings to get feedback on draft County Parks Strategic Plan. Staff is revising the plan based on this feedback and plans to present a proposed final draft to the Parks and Recreation Commission on August 6.

NORTH COUNTY PARKS (Highlands, Ben Lomond, Felton Covered Bridge, Probation, Michael Gray Field, Quail Hollow Ranch and the North Coast)

Quail Hollow/Pace Property Trail Planning

The Zoning Administrator approved the development permit for the trail network additions to the Pace Property on at hearing on April 20th. We are waiting to hear if the Habitat Conservation Fund grant will be awarded for this project before proceeding.

Quail Hollow

Planning, Recreation and Programming staff work on the interpretive signage is currently onhold as other work is taking priority.

Felton Library

Staff is working with consultants to prepare a site plan for the park next to the new Felton Library, and will hold a community meeting on June 14th to get community input. State Parks awarded the Outdoor Education Facilities Grant for this project for \$395,000.

MID-COUNTY PARKS (AJC, Government Center, Emeline Complex, Twin Lakes, Brommer, Felt, Floral, Coffee Lane, Soquel Lyons, Jose Avenue, Winkle Farm, Willowbrook Lane, Moran Lake, Maplethorpe, Santa Cruz Gardens, Heart of Soquel Plaza, The Farm, Mid-County beach access areas)

<u>Chanticleer Park</u>: The Santa Cruz Playground Project has continued their fundraising efforts. The County's consultants have prepared a first draft of the 75% construction documents. Staff submitted the building permit application to the Building Department for review.

Heart of Soquel Phase 2 & 3

The Heart of Soquel Phase 3 conceptual plans were well received by the Soquel Elementary School Board of Trustees on March 21st. Due to this positive response, the appraisal report

was completed, and Parks Planning staff, the County's Chief of Real Property and the design team members met with the School District Employees to further develop the plans and agreements for the School Board of Trustees future consideration. Currently, Parks Planning Staff and the Chief of Real Property are preparing the draft purchase agreement and Parks Planning Staff and the design team members are preparing other material for the School District Board of Trustees information at their June 6th meeting. Acquisition of the other remaining privately-owned property was approved by the Board of Supervisors on April 10th. Two grant applications are pending approval.

Farm Phase 2

Currently, the consultant's work on completing the 90% plans is on-hold until a response to the Planning Department is finalized. Planning & Maintenance staff met with the Project's Biologist to prepare for an upcoming volunteer day scheduled for June 11th and to discuss future means and methods of reducing irrigation needs, the biotic report's required outcomes and future planting plans.

Hidden Beach

Park Planning, Maintenance and Fiscal staff have been working on a "Let's Play Grant" for \$50,000 with a \$50,000 Match for a replacement playground using the Kompan Pirate theme. Only five grants will be awarded in the United States. However, the community is excited about the prospect of receiving a replacement playground, as the Rio Del Mar Association recently raised \$1,500 with the "Human Race" fundraiser and the Parks Department has received a private donation of \$12,000.

<u>Willowbrook</u>- Park Planning and Maintenance staff met with Pickleball representatives to discuss creating permanent pickle ball courts with a verbal commitment of 50% match based on a construction estimate of \$80,000.

SOUTH COUNTY PARKS (Polo Grounds, Valencia Hall, Hidden Beach, Seascape, Aptos Village, South County Beach access areas, Scott Park, Scott Estate, Aldridge Lane, Mesa Village, Pinto Lake, Seacliff Village Park, Freedom Government Annex)

Pinto Lake

Staff have submitted and re-submitted a grading permit application to Environmental Planning for the proposed pump track. Staff is working with General Services Department to solicit bids from contractors for the site preparation work. Staff is also continuing to work with partners at the Resource Conservation District, City of Watsonville and Watsonville Wetlands Watch on planting natives in the vegetated filter strip area for increased erosion control for the project.

SeaCliff Village

Park Planning and the Planning Department are continuing to coordinate efforts to evaluate the potential planning process and permit requirements for implementing alternative skate feature designs. Also, Park Planning and members of the public are discussing installing a shade structure and/or shade trees with the help of a private donation of \$5,000.

Swim lessons – Spring lessons are held on Tuesday and Thursday mornings from 9am – 12:30pm until May 24th and Monday/Wednesday/Friday and Tuesday/Thursday evenings from 4:00 – 7:30 pm until June 8th.

Summer Programs Begin June 11 – Summer swim lessons and our popular Junior and Little Guard programs begin June 11th. Currently both morning and afternoon Junior and Little Guard programs for all three summer sessions are full with long waiting lists.

Water Polo - Sundays from 10:30 am - 12:30 pm.

Aquatic Staff Hire - The department hired 19 new extra-help Lifeguards and 3 new extra-help Head Lifeguards.

Private Pool Parties – Private Pool Parties are available on Saturdays & Sundays. A variety of aspects of the facility may be rented for Private Pool Parties, from just the warm pool to aspects accommodating up to 110 people. Private Pool Parties are scheduled on weekends, spring, summer and fall, after the facility has closed to the public.

School Parties – Once again local schools will be renting the facility for their end of the year parties starting May 23rd and continuing until June 8th.

Adult Fitness Swimming - Adult Fitness Swimming is very popular at the Simpkins Family Swim Center. The best-attended workouts are Tuesday and Saturday mornings; up to 35 swimmers fill the 50-meter pool at these times. Fitness swimmers may choose from several different workout times: Monday's 6:00 am; Tuesday, Wednesday, Thursday and Friday workouts are at 6:00 a.m. and 12:00 p.m.; Saturday and Sunday at 9:00 a.m.

For the past four months we have been offering an Introduction to Lap Swimming Class and an Introduction to Adult Fitness class on Wednesday and Thursday mornings which have continually gained attendance numbers.

Adult Fitness Swim Meet - Adult Fitness swimmers had their second swim meet on April 14th from 8am – 11 am. It featured 25, 50, and 100-yard races of all four strokes and occurred with regularly scheduled programming.

Water Aerobics & Exercise - The water exercise classes this year continue to reach their high capacity. Water exercise is an excellent way for people to meet their fitness goals without impact on the joints. Classes are designed to appeal to all levels of ability including, healthy, pre-natal, seniors, and rehabilitating or cross training fitness enthusiasts. A monthly calendar is available with dates, times and instructor's names. Previous swimming or water-exercise experience is not required for participation in any of the water exercise classes.

Lifeguard Training Exercises – The lifeguard in-service in May was shallow water spinal rescues.

For June we will have two very large in-service trainings with all staff included in preparation for the busy summer season.

Swim Teams - The Aptos Cabrillo Swim Club and QuickSilver Swimming - swim teams continue to rent lanes in the 50-meter pool. The swim teams offer school-age competitive swimming programs Monday through Friday from 4:00-7:30 p.m.

Pool Closures and Holiday Schedule

There are no scheduled pool closures in May, June, or July.

Live Oak Community Rooms - The Live Oak Community Rooms at the swim center are rented out regularly throughout the year for meetings, small events and classes.

Art Exhibitions

Artist of the Year

Conductor Cheryl Anderson has been named the 2018 Artist of the Year by the Santa Cruz County Arts Commission. Please join us at 7:00 p.m. on Friday, June 1 at Samper Recital Hall at Cabrillo College for a Profile Performance - a concert featuring members of Cabrillo Symphonic Chorus, Cabrillo Chorale, Cantiamo!, Cabrillo Youth Choruses, II Dolce Suono, and Peace Chancel Choir. Admission is FREE to the public; seating is limited and available on a first-come, first-served basis the night of the event.

Cheryl is in her 26th year as Director of Choral and Vocal Studies at Cabrillo College. During her time at Cabrillo she has taught a variety of music, as well as serving as Conductor of Cabrillo Symphonic Chorus, Cantiamo!, Cabrillo Chorale, and Cabrillo Opera, which she founded. She is also Founder/Artistic Director of the Cabrillo Youth Choir Project. She also serves on the Music Education Faculty at San Jose State University. The various choirs under Cheryl's direction have sung concert tours all over the world, including the Vatican in Italy, Carnegie Hall in New York, and tours through California performing with Lou Harrison his masterwork La Koro Sutro and the internationally famous Incheon City Chorale from South Korea at Davies Symphony Hall.

YOUTH RECREATION PROGRAMS

Mar Vista ACE

April began with Majestic Creatures Week and featured activities such as: unicorn art, Troll Walk, Fairy Houses and a field trip to Marianne's Ice Cream and Seacliff Village Park. Next was Technology and Earth Week. Projects and games included: Protect the Computer, an animation project, Cell Phone vs. Retro (game), Earth science and earth ball. The highlight of the week was a mini carnival and petting zoo. Participants always have a blast during this festive event. April drew to a close with Mother Nature Wonders Week. We played games such as: Fire in the Forest, Nature's Place, Bobcat vs. Prey and Nature Four Square. Projects included: leaf people, nature "stained glass," and nest building.

Transportation Week got May "rolling" with activities such as: Indy 500, design your own car, Wheel of Fortune, Matchbox car table track design. The highlight of the week was Wheels Day, during which participants got to bring their non-motorized wheels (e.g., bikes) and power them through an obstacle course and rounds of Red Light, Green Light. Appreciation Week was next and included: Inverted Kickball, nature art frames, Protect the Teacher, rock painting, Mother's Day cards and a field trip to the Boardwalk Bowl and Neptune's Kingdom for miniature golf. One of the favorite recent activities was handmade picture frames, created from popsicle sticks and decorated with: yarn, glitter, stickers, and kind sentiments from their friends in the program. We will be taking pictures of them to fill their frame. Staff hope that they will serve as a memento of the good times they had with us this year. One of the GIRLS favorite food projects was making Mexican fruit cups. They really enjoyed cutting the fruit in specific ways and arranging them to make their fruit cups not only taste delicious, but to look beautiful as well! We have also been playing a variety of team-building games. One of their favorites, Who Stole My Coconut, pushes them to self-organize in a group, strategize, and work as a team to get the coconut across the line. During a recent school closure day, we offered a First Aid and CPR training class for participants. Five girls chose to forego sleeping in to take the 6-hour course!

La Selva Beach ACE is preparing to finish a wonderful school year and headed towards an exciting La Selva Beach Summer Camp! Recent themes at La Selva Beach ACE include Appreciation Week which featured activities such as a mini roller coasters project, ice cream sundaes, capture the flag, Mother's Day Cards, a sports obstacle course, old school dodgeball, and a spring tree craft as a gift for Mother's Day. Our most current theme is Sea Creatures, which includes a turtle craft, island tag, sea creatures print art, a game of octopus, an aquarium craft, a new seahorse craft and a game of sea, shore, sand. The highlight for Sea Creatures week was a field trip to Manresa Beach. We also took a field trip to the Simpkins Swim Center. The children at La Selva Beach ACE are continuing to go to the library on Tuesday afternoons for some homework help and on Thursday afternoons for a Minecraft session. The parks youth division also recently had our annual summer youth volunteer training. Twenty youths ages 12-16 years participated in the training.

QUAIL HOLLOW RANCH INTERPRETIVE PROGRAMS

April was an exciting month for Quail Hollow Ranch. One of our most popular programs, Trek to the Forbidden Sandhills led by Park Docent Sean Wharton, ran each Sunday, with the final three hikes full, with wait lists. In addition, we hosted two Plein Air Painting classes, a workshop on Sourdough bread and bread science, a house tour, and a composting class in conjunction with Santa Cruz County Public Works. We have been working with the UC Master Gardeners to offer several public education courses at the ranch, and on May 29, Renee Shepherd of Renee's Seeds led a class on planting a great garden from seed. Almost 50 people were in attendance! County Parks and Quail Hollow Ranch were representing down in Watsonville at an Earth Day event and festival, where we connected with hundreds of community members. Craig Wandke from the Santa Cruz Astronomy Club was up at the Ranch where he gave a fascinating and engaging presentation on our moon, followed by a clear evening of moon gazing.

The proposal for the Pace Property Trail development was approved by the zoning administrator for the county and we are currently awaiting the decision on a grant that will help us fund that project.

In May QHR was lucky enough to have San Lorenzo Valley Rotary Club here to help us paint the fence of our public corral. They were tenacious workers, and have scheduled two more volunteer paint days! Two of our committed Nest Box volunteers represented our program at the first annual Natural Brides Migratory Bird Day. They brought with them nest boxes and step by step directions of how-to-build your own box. Their booth saw a lot of heavy traffic of people interested in building backyard nest boxes. Quail Hollow Montessori School and Terra Pacifica came to the ranch for outdoor education field trips on insects and habitats. The Santa Cruz Fly Fishermen were at Quail Hollow Ranch for an all-day BBQ and fly-fishing expose. They had a fly tying workshop, a presentation on the basics of fly fishing, and experts there to teach people how to cast. As there is no fishing in the QHR pond, they were just on the field practicing, but still, they had a great time!

We are gearing up for summer camps here and hoping we get lots of participants. Science Sleuths will visit the children's discovery museum in San Jose. We are putting new trail signs up on the trails, and installing to bat houses in hopes of giving bats and abode, and starting up bat programs once again at Quail Hollow.

North County

Scott Creek Beach

The Tau Kappa Phi fraternity had their first work day since they adopted Scott Creek Beach and they had 45 Brothers turn out. They continued their work on removing sand, removed a dump truck full of invasive ice plant, and covered up graffiti.







Quail Hollow Ranch

Some members of the San Lorenzo Rotary Club spent a couple hours at Quail Hollow Ranch volunteering their time to trim back overgrown shrubs and paint fences.





In April and May, the Trail Crew Volunteers logged approximately 79 hours of trail maintenance to keep the trails accessible and in good shape for hikers and equestrians. Also, the Broom Bash volunteers logged approximately 271 hours removing French Broom.

The Santa Cruz Astronomy Club provided FREE Star Gazing experiences at Quail Hollow Ranch in April and May. The club provides volunteers who bring their telescopes and educate the community. For Aprils viewing the club provided 5 volunteers for over 5 hours and over 30 community members were in attendance.

The Bird Nest Box Volunteers have been busy in April and May volunteering approximately 125 hours monitoring the nest boxes and documenting the bird activity.

Miller Property

The Miller Property volunteers have logged over 75 hours in April and May repairing trail damage from illegal motorcycle use, picking up trash, removing French Broom, and keeping signage posted.

Mid County

Anna Jean Cummings Park

We have a new volunteer who has joined the efforts to locate and assist the maintenance staff with cleaning up abandoned homeless camps, and picking up trash. The two volunteers have logged over 50 hours in April and May.

Jose Ave. Park

A community member offered to volunteer their time to fix the art work at Jose Ave. Park. She has started the project and is hoping to engage the children that frequent the park to help with the project.



South County

Polo Grounds Park

We have one active volunteer at the dog park who will be helping to maintain the dog park area. He will be helping maintenance spread mulch, and assisting them in their efforts to keep the foxtails to a minimum.

Pinto Lake Park

Pinto Lake volunteers have logged over 40 hours in April and May in graffiti abatement and Disc Golf Course maintenance.

Volunteers for the Community Emergency Response Team (CERT), in Rio Del Mar, volunteered their time to clean up the empty lot at the Esplanade. After they cleaned up the lot, they held a rummage sale as a fundraiser for the CERT program on the lot.



Formed in 1959, the Boulder Creek Recreation and Park District's service area contains approximately 16 square miles with the District primarily serving the communities of Boulder Creek and Brookdale.

The District's six facilities are:

- Garrahan Park, 15530 Highway 9 in north Boulder Creek (Playfield, Playgrounds, Picnic Areas, Skateboard Ramp, Walking Path, Exercise Equipment)
- Junction Park on Middleton Avenue at the junction of Boulder Creek and the San Lorenzo River, (Picnic Area, River Access, Small Lawn)
- Barbara Day Park on East Lomond Street at the dam site on San Lorenzo River (Passive Recreation, River Access)
- Recreation Hall and office, 13333 Middleton Avenue, Boulder Creek (Office, Recreation Hall, Playground)
- KBCZ Community Radio Station, 13200 Highway 9, Boulder Creek (a program of BCRPD, non-commercial/educational community radio station run by community volunteers)
- Bear Creek Recreation and Community Center on 15685 Forest Hill Drive, Boulder Creek (Community pool, wedding and event rental venue, tennis courts, exercise facility, picnic area, community garden)











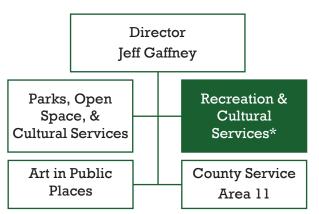

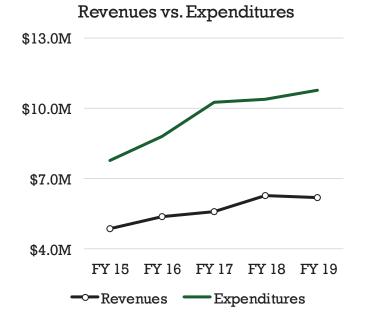

ORGANIZATIONAL CHART

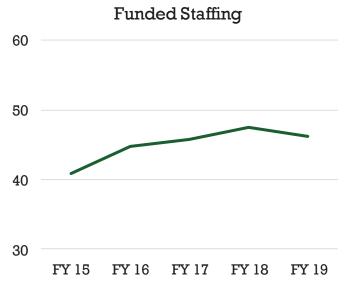

5-YEAR TRENDS



The gap between expenditures and revenues is financed by a combination of General Fund contributions and available fund balance.



In 2014-15, Parks was restored as a separate department and positions have been gradually restored: 7 in 2014-15, 3.95 in 2015-16, 1.50 in 2016-17, and 1.75 in 2017-18 (partially grant-funded). Unfunding 2 positions and restoring one three-quarter time position is recommended for 2018-19.

PARKS OVERVIEW

MISSION

The Mission of the Santa Cruz County Parks, Open Space, and Cultural Services is to provide safe, well-designed and maintained parks and a wide variety of recreational and cultural opportunities for our diverse community.

PARKS, OPEN SPACE, & CULTURAL SERVICES

Parks, Open Space, and Cultural Services, commonly referred to as Parks, is responsible for 1,400 acres of County park land, the Simpkins Family Swim Center, multiple County beach access points, a variety of after-school and summer recreational programs and cultural services programs. Parks provides staff to the County's Parks and Recreation Commission and the County's Arts Commission.

RECREATION & CULTURAL SERVICES

Recreation and Cultural Services is discussed separately starting on Page 171

ART IN PUBLIC PLACES

Art in Public Places provides art in the development of County building and remodeling projects with construction costs over \$100,000, as well as public art in highly visible public areas for the general public's enjoyment.

COUNTY SERVICE AREA 11

County Service Area 11 (CSA 11) encompasses the entire county except for the four cities and the independent recreation districts of Alba, Boulder Creek, La Selva, and Opal Cliffs. It provides funds for park acquisition, park development and maintenance, recreation programs, and the overall operation of the Parks Department.

BUDGET OVERVIEW

2018-19 RECOMMENDED BUDGET

The 2018-19 recommended budget provides for an increase of \$299,034 in expenditures and a decrease of \$445,772 in revenues, resulting in a \$380,850 increase in Other Funds and a \$363,956 increase in General Fund contribution. Reserves of \$736,694 in CSA 11 and \$59,779 in Art in Public Places remain for future repairs and maintenance.

EXPENDITURES

The increase of \$310,633 in Salaries and Benefits is due to cost increases for existing staff and the restoration of 0.75 Full Time Equivalent (FTE) Recreation Program Specialist.

The decrease of \$13,598 in Services and Supplies is due to increased costs in Parks Services from CSA 11 and utility costs, which are offset by a decrease of \$432,189 in expenditures associated with the repairs of 2016-17 Storm Events.

FIXED ASSETS

The budget includes \$310,000 for one-time fixed assets to replace obsolete field equipment and

potential capital projects, and \$13,500 in Public Art improvements.

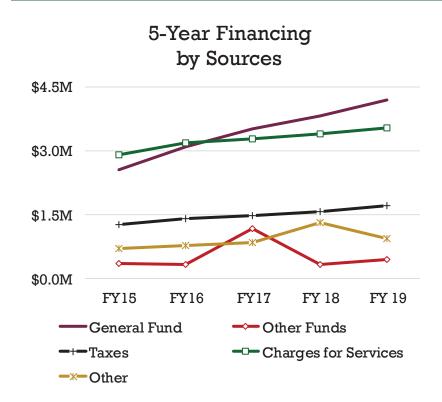
REVENUES

The decrease of \$431,095 in Intergovernmental revenues results from the anticipated completion of 2016-17 Storm FEMA/CalOES reimbursements. Revenues also decreased by \$367,816 in Charges for Services as a result of a one-time refund to taxpayers due to CSA 11completed debt service, and \$13,407 in Miscellaneous due to the completion of a programming grant. Decreases are offset by increases of \$148,814 in Taxes, \$59,138 in Use of Money, and \$158,594 in Charges for Services.

STAFFING

The budget includes the restoration of a 0.75 FTE Recreation Program Specialist, and the unfunding of 2.0 vacant positions in Maintenance.

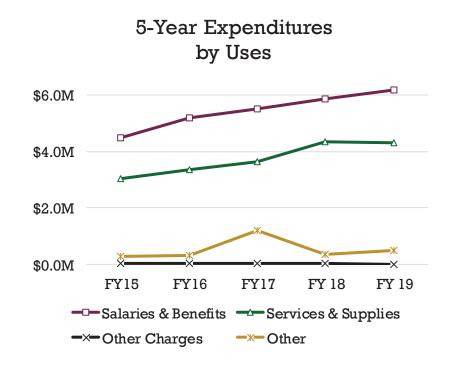

BUDGET OVERVIEW

RECREATION & CULTURAL SERVICES

The budget provides funding for contracts with various community partners to provide cultural and recreational services.

Arts Council of Santa Cruz County: The \$170,046 contract with the Arts Council is to provide a broad range of arts, entertainment and educational activities benefiting County residents and visitors. These programs include workshops, grants to existing programs such as SPECTRA (Arts in Education), and overall coordination of arts activities in the County. The Arts Commission annually reviews the activities of the Arts Council.

The Museum of Art & History (MAH) at the McPherson Center: The \$154,594 contract with the MAH provides for the operation and maintenance of the MAH, liaison services to the Historical Resources Commission, and development of historic preservation services throughout the County. MAH's strategic vision is to share its excitement and passion for both history and contemporary art to all residents through exhibitions, educational programs, and opportunities for research in the organization's archives. Pursuant to the agreement between the County and MAH, the organization retains any

revenues generated by activities under the agreement to expand historical services.

Santa Cruz County Veterans Memorial Building (SCCVMB): The \$76,650 contract with the Santa Cruz County Veterans Memorial Building Board of Trustees (SCCVMBT) provides for the operation and maintenance of the Santa Cruz County Veterans Memorial Building.

Recreation Programs: Contract providers include Loma Prieta Community Foundation to provide year -round recreation and leisure activities at the Loma Prieta Community Foundation Center, Community Action Board to provide the Davenport Teens year-round and summer programs, Pacific Elementary School to provide youth recreation programs for the Davenport Community, San Lorenzo Valley Youth Council and YWCA Watsonville to provide summer recreation opportunities for Santa Cruz County Youth. The recommended budget allocates a total of \$37,109 for recreation contracts.

2018-19 RECOMMENDED BUDGET

The 2018-19 recommended budget provides for a decrease of \$78,610 in expenditures due to the use of one-time funds for security cameras. The decrease in expenditures results in a \$78,610 decrease in General Fund contribution.

PLANT ACQUISITION

OVERVIEW

The Plant Acquisition budget provides appropriations and revenues for capital projects with a cost in excess of \$25,000. Projects with an estimated cost of less than \$25,000 are budgeted in the General Services Department building maintenance budget. Many capital projects have several sources of funding, therefore, specific projects may be reflected on several different funding pages. Projects and corresponding revenues are maintained in the Capital Improvement Fund until completion. Expenditures and revenues are re-budgeted and re-allocated as part of the Adopted Budget process. Project listings for all funds can be found in the Appendix.

CIP

The CIP presents a five-year financing implementation plan for capital improvements within the unincorporated County. It is an outgrowth of cooperative planning, programming, and financing efforts through the County Administrative Office and by County departments including General Services, Parks, Open Space and Cultural Services, and Public Works. Several CIP project highlights are included in the Proposed Budget starting on pages 339 and 346. The full CIP document will be presented to the Board of Supervisors separately in late May.

COUNTY FACILITIES (FUND 40)

During FY 2017-18, the County continued to make progress on deferred maintenance which is estimated at over \$80 million. Existing projects approved in previous years continue in the amount of \$79.6 million that is primarily funded through grants totaling \$41.6 million and other financing of \$30.8 million.

In 2017-18, a transfer of \$1.5 million from County Buildings to the Juvenile Hall Gym Renovation

project is recommended to ensure sufficient funds are available to award the construction contract which will begin in 2018-19.

Projects such as the construction of the Rountree Re-entry Program Facility and Main Jail shower replacement, and energy efficiency upgrades are scheduled for completion in 2017-18. The Health Services Agency also has numerous projects funded in 2017-18 that will continue in 2018-19, including Behavioral Health Facilities in Santa Cruz and Watsonville. The Felton Library contract is also scheduled to be awarded in 2017-18 with construction scheduled for completion in 2018-19. Deferred maintenance on aging County facilities continues to be an ongoing concern. In 2018-19, the General Fund is providing \$750,795 to begin to address these needs.

FORMER REDEVELOPMENT FUNDS (FUND 42 & 43)

The former Redevelopment Agency (RDA) funds provide for contributions from the Santa Cruz County Redevelopment Agency, dissolved on February 1, 2012, to the Capital Improvements Fund (from Capital Bond funds) and Projects-Various Fund (from Capital Tax Increment funds), per the County-Redevelopment Amended and Restated Cooperation Agreement. Projects and corresponding revenues are reflected in these funds until project completion.

For 2018-19, work will continue on those capital projects that were approved in 2010-11. Priority projects include: Phase 2 of the Heart of Soquel Park and Parking project, currently in the conceptual design phase. The Twin Lakes Beach project is scheduled for completion in 2017-18.

PARKS SPECIAL PROJECTS (FUND 49) & STATE PARK BOND FUNDS

Projects in the Parks Special Projects are funded by

the previous sale of County-owned and former Redevelopment Agency-owned properties in Aptos, Live Oak and Soquel. The proceeds from the sale were specifically designated by the Board of Supervisors to be utilized for park projects.

State Park Bond Funds are grants from the State of California for specific park projects. While no new funds are currently expected in 2018-19, Parks continues to apply for grants, which will then be accepted as unanticipated revenue into this budget once awarded.

PARK DEDICATION FUNDS

Park Dedication funds provide appropriations and revenues for projects within specific park dedication districts. Residential building permit fees, specifically for Parks, are based on number of bedrooms per dwelling from new construction or residential remodels. The funds are comprised of 15 park special districts, four park recreation districts and two additional funds for bond reserves and interest. Because many areas of the County are at maximum development, funding can fluctuate from year to year depending upon economic conditions. Residential park development fees have not been raised since 1998-99. A fee study is currently in process to provide recommendations on an updated fee schedule.

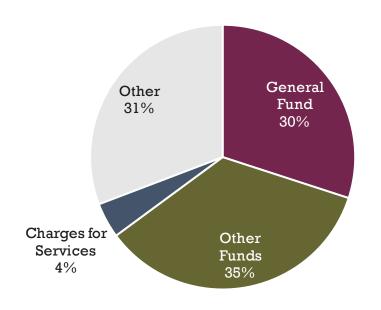
The San Lorenzo Park Dedication District (SLPDD) fund includes previously borrowed funds from both the General Fund and the Skyline Park Dedication District that must be repaid. In 2018-19, the SLPDD will pay \$6,400 to the General Fund. The SLPDD will pay the remaining General Fund balance and \$150,000 owed to the Skyline Park Dedication District with fees collected in future years.

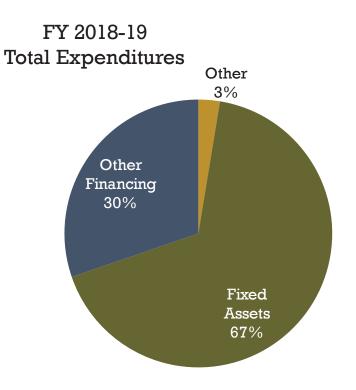

Dear Santa Cruz County Parks and Recreation Commissioners:

As you may recall, Friends of Santa Cruz County Parks (FSCCoP) is a 501(c)(3) non-profit organization that has provided support and assistance to Santa Cruz County park, art and recreation programs and services since 1987. The FSCCoP By-laws state the FSCCoP Board of Directors shall consist of at least five (5), but no more than fifteen (15) directors and that directors shall be nominated and approved by the Santa Cruz County Parks and Recreation Commission.

I am extremely pleased to nominate and recommend approval of <u>TERESA CORWIN</u>, <u>TRICIA POTTS</u> and <u>MARIAH ROBERTS</u> to the Friends of Santa Cruz County Parks Board of Directors.

Throughout the past several years, each of these highly accomplished nominees has exhibited sophisticated leadership and diplomatic skills when working with the public; with elected representatives; and with the SC County Department of Parks, Open Space and Cultural Services staff on park and capital improvement projects ranging from building SC County's first all-inclusive playground to protecting agricultural land and open space from being re-zoned for development.

After becoming a CPA, <u>TERRY CORWIN</u> spent the early years of her business career in corporate finance. Hired in 2005 by the Santa Cruz Land Trust, Terry spent the next 11 years as the Executive Director and President. Under Terry's leadership, the Land Trust now protects over 10,442-acres of natural lands with high conservation value and has raised \$38 million toward land protection. Terry retired in 2017 and looks forward to strengthening and growing the non-profit Friends of Santa Cruz County Parks.

In 2012, <u>MARIAH ROBERTS</u> founded the non-profit, Chanticleer Park Neighbors/Vecinos Association [CPNA]. Working with the county through a system of use permits for its volunteers, the CPNA followed the layout of the Park's Master Plan, clearing out the debris and overgrown weeds making Chanticleer Park a safe and inviting place to play. A playground grant from the non-profit, KaBoom was the first of the many grants scored by

Mariah. In 2015, Mariah was the well-deserved recipient of The Volunteer Center of Santa Cruz County's, "Be The Difference Award."

In 2013, <u>TRICIA POTTS</u> and her husband, Bob took their three children to the opening of "Tatum's Garden," the newly built all-inclusive playground in Salinas. It was a day of firsts for the Potts family. Their youngest child had just been fitted for his first wheelchair. And, the universal design of the park and play structures meant it was the first time the three children were able to play together.

During the following weeks and months, Tricia plunged into tireless action, meeting with Betsey Lynberg, Gretchen Iliff and the SHARP/FSCCoP Board of Directors to share her family's experiences and find a suitable county park site. Tricia was determined an all-inclusive playground would be built in Santa Cruz County while her son was still young enough to enjoy it.

Tricia's Santa Cruz Playground Project quickly teamed with Chanticleer Neighbors Association. Mariah and Tricia's six-year grassroots campaign to raise the millions of dollars needed to build LEO's Haven in Chanticleer County Park is likely to become a reality in 2019.

I, again, encourage the SC County Parks & Recreation Commissioners approve the nomination and appointment of <u>TERESA CORWIN</u>, <u>MARIAH ROBERTS</u> and <u>TRICIA POTTS</u> to the Friends of Santa Cruz County Board of Directors.
