# Kinder Enrichment & Transitional Kinder Program Information

## August 15-31, 2018



The Kinder Enrichment (KE) and Transitional Kinder (TK) Programs provide a safe and enjoyable recreational/educational experience for kindergarten and transitional-kinder children. Participants will enjoy stories, art, music, science, creative play, active games, sport basics and a balance of individual and group activities, indoors as well as outdoors. When you register your child for the program for the first time during the school year, you will receive an information handbook and an emergency information card.

Mid and PM Kinder programs will be joined with the ACE Program for some activities. Please be sure to review the information in the handbook, and fill out the emergency card completely. The emergency card must be given to the site staff on the first day your child attends the program. **Please note:** \*Non-Restructured Wednesdays are included in 100% AM/MID/PM plans and are available to choose in 50% plans. **AM KE/TK hours:** M, Tu, Th, F - 7:30-10:50 a.m.

**MID KE/TK hours:** M, Tu, Th, F - 11:35 a.m.-2:20 p.m.

**PM KE/TK hours:** M, Tu, Th, F - 2:20-6:00 p.m. **\*Restructured days (most Wednesdays) 12:35 p.m.-6:00 p.m.**

### Registration Options & Fees

#### 100% (M, Tu, Th, F + W 8/15)

The part-time options allow you to choose the days which are convenient for your schedule.

### What does Non-Res mean?

\*\*A Non-Resident is a person(s) living in one of the 4 cities (Santa Cruz, Capitola, Watsonville, Scotts Valley) or one of the 4 special recreation districts (Alba, Opal Cliffs, La Selva Beach, & Boulder Creek).

### Enrollment is Limited!

Registration is taken on a first-come, first-served basis each month. Registration fees and information for the following month will be available by the 10th of the previous month.

### Important!

**Parents of part-time participants must complete a part-time calendar.** Part-time calendars are vital to establishing correct staff-to-child ratios. This can be done online (EzReg) by entering the days your child will attend the program when prompted to do so. If you are using fax or mail-in registration, please circle the days you have chosen on the registration form (see reverse). **This is important, so staff will know which children to pick up from their kindergarten classrooms.**

### Sibling Discount

There is a discount of 15% for each additional sibling who is registered for the same session of the ACE or Kinder Enrichment programs. The discount will be taken off the equal or lower-cost program option (e.g. for August, one child in 100% and one child in 60%, the 15% comes off the 60% fee). Please include the amount to subtract for the sibling discount on the second child's registration form, and write the total fee due for the month for both children in the "total due" space. To use the sibling discount option, you must register via phone, fax, or mail (not available for online registration).

### Please Note

Wed., August 15 is NOT restructured; all other Wednesdays in August are restructured.
