To be considered as a vendor for the 2017 Art & Craft Faire, you must submit by October 13, 2017:

1. Your application filled out completely and legibly.
2. Five (5) images of your work. Include your name, address, phone, and media used for each of your images.
3. Booth fee, payable by check, Visa or MasterCard.

Criteria: All work must be original, and designed and produced by the exhibiting artist. If you work with others and/or have anyone other than yourself involved in the design and/or production of your work, you must include a statement that fully describes both your specific involvement and the contribution of others to the design and production of the work. We do not accept factory-made items. The artist/craftsperson must be present to host their booth; no representatives are to be sent in place of the artist or craftsperson. Padding of booths with resale items is NOT ALLOWED.

Jurying Procedure and Time Line: Vendors must submit 5 color images of their work to be considered for participation in the 2017 Art and Craft Faire. Vendors may submit hard-copy photos with name and address on reverse (photocopies okay) or a CD with jpg or tif images (formatted for PC). Each digital image should be no larger than 1500 X 1500 pixels, 300 dpi and 2 MB. You may mail or hand-carry your photos or CD to: Attn: Kathy DeWild, Santa Cruz County Parks, 979 17th Ave., Santa Cruz, CA 95062.

Notification of Acceptance: After the jury process occurs, all vendors will be notified of the jury decisions. All decisions are final. Those accepted will receive complete event information, as well as booth size and location. Notification will be sent via email to vendors the week of October 23, 2017. If you have not received notification by November 5, please email to events@scparks.com to inquire. Please note: If the jury does not accept your items for inclusion in the 2017 Art and Craft Faire, your booth application information and any checks received will be shredded. If you wish to have your application materials returned to you, you must include a self-addressed, stamped envelope with sufficient postage.
